V. REPORT OF CITY OFFICIALS:

Report of Fiscal Officer Tracy Evans:

- > Passed around monthly reports for Council to sign.
- ➤ Informed Council the bid for the Lovers Lane project may come under what was originally projected.
- Requested income tax refunds for \$14.10 & \$69.
 - *Scott Willey moved and Shawn Priest seconded to approve the above income tax refunds. Roll call vote 5-0. Motion carried.
- ➤ Updated Council that solar lights have been ordered for the mural and new flag pole at the Roadside Rest Park.
- ➤ Informed Council the Altrusa Club asked to install a free library at the playground and wanted to ask Council if it does not work out in that location can they place it at the park downtown by the mural?

 After discussion, Council said they had no problem with the library being installed in the downtown area. Solicitor Beery stated no vote was needed.

Report of Police Chief Shane Nolley:

Chief Shane Nolley reported that for the month of April 2017, there were 505 calls for service. Hours worked were as followed: Chief Nolley-160 regular, 0 overtime; Officer Stephens-160 regular, 0 overtime; Officer Brady-91.5 regular, 0 overtime; Officer Michael-90 regular, 0 overtime and Officer Cottrell-110 regular, 0 overtime. There was 1 Traffic Crash Report, and 17 Offense Reports. Arrest Information: Arrests - 3, Traffic Citations -5, and Warning Citations - 12. Police vehicle information: Unit 1 - 2006 Crown Victoria out of service, Unit 2 - 2005 Ford Explorer – 1,054 miles driven, Unit 3 - 2015 Police Interceptor – 1,772 miles driven. Repairs: \$40.85 and Training: \$0.

Report of Mayor Freddie Snyder:

Mayor Snyder informed Council that Candle-lite want to dispose of their holding tanks that were installed for fire protection and hook in to the Villages 10' main. The Mayor is concerned with this because if Candle-lite would have a fire and their pump would kick on, it would drain our water tower (which only holds 350,000 gallons of water) in a matter of minutes. Steve Canter with Environmental Engineering (our Utility operator) and Fire Chief Kenny Stevens met with Candle-lite and told them they could not remove the holding tanks for safety reasons.
